Regulation (EC) No. 1069/2009 of the European Parliament and of the Council of 21 October 2009 laying down health rules concerning animal by-products not intended for human consumption

The Animal By-Products (Enforcement) (England) Regulations 2013

Approval of biogas plant*

1. In accordance with Regulation 14 of The Animal By-Products (Enforcement) (England) Regulations 2013 and Articles 24 and 44 of Regulation (EC) No. 1069/2009, the Secretary of State approves:

to operate a biogas plant* on the premises to treat Category 3 animal by-products including catering waste and permitted category 2 animal by-products in accordance with the Annex.

2. Samples of the treated product shall be taken once per month (a) after treatment and tested for E. coil (or Enterococcaceae) and (b) during storage and tested for Salmonella - at a laboratory with the appropriate UKAS accreditation.
3. This approval has no expiry date, but may be suspended or revoked in event of non-compliance with the above Regulations.

Annex

1. The animal by-products/catering waste* must be reduced in size to a particle size of no more than 12 mm using EITHER (a) Manufacturer: Vogelsang. Model: Rotacut RCQ. Type: RCQ-33 PRO COMPACT XL. Serial No: EJE.3130.1018. Your ID: 03.01.RC1. OR (b) Manufacturer: Vogelsang. Model: Rotacut RCQ. Type: RCQ-33 PRO COMPACT XL. Serial No: EJE.3130.1017. Your ID: 03.01.RC2. and treated in one of the three pasteurization units in such a way that the animal by-products/catering waste* achieve a temperature of at least 70 degrees Celsius continuously for a minimum time of 60 minutes before moving into the digestion tanks.

Notes

1. Processed (rendered) material derived from Category 1 material may not be treated in a composting or biogas plant. If other processed material is treated in a composting or biogas plant, it must have been produced by:
 - (a) processing Category 2 animal by-products by method 1 in an approved processing plant;
 - (b) processing Category 3 animal by-products by one of methods 1-7 in an approved processing plant.
2. The following Category 2 materials can be used in compost and biogas plants operating to EU standards without prior method 1 processing:
 - manure
 - digestive tract and its content from carcasses passed fit for human consumption in an abattoir
 - milk, colostrum and milk based products
 - eggs and egg products
 - which the competent authority does not consider to present a risk for the spread of any serious transmissible disease.
3. The following Category 2 materials can be used in compost and biogas plants operating to national standards without prior method 1 processing:
 - manure
 - digestive tract content separated from the digestive tract
 - milk, colostrum and milk based products
 - eggs and egg products
 - which the competent authority does not consider to present a risk for the spread of any serious transmissible disease.
4. The following Category 2 materials can be used in compost and biogas plants without the need for pasteurisation:
 - manure
 - digestive tract content separated from the digestive tract
 - milk, milk based products and colostrum
 - which the competent authority does not consider to present a risk for the spread of any serious transmissible disease.
5. All the conditions of The Animal By-Products (Enforcement) (England) Regulations 2013/The Animal By-Products (Enforcement) (Wales) Regulations 2014 and Regulation (EC) No. 1069/2009 and Regulation (EU) No. 142/2011 must be complied with.
6. In the event of an unsatisfactory microbiological result, the Animal and Plant Health Agency (APHA) must be informed immediately and the procedure in the HACCP plan followed.
7. Changes to the ownership, address or operation of an approved animal by-product premises must be notified to APHA at the address above.

APHA is an Executive Agency of the Department for Environment, Food and Rural Affairs and also works on behalf of the Scottish Government, Welsh Government and Food Standards Agency to safeguard animal and plant health for the benefit of people, the environment and the economy.
